1. What is the MPO Benefit Concert 2026?

2. Who will be featured in the concert?

The concert will feature Malaysian music icon Sheila Majid in celebration of her remarkable 40-year musical journey, together with the Malaysian Philharmonic Orchestra, conducted by Ahmad Muriz Che Rose.

7. What are the available contribution categories?

8. Is there a transaction fee?

Yes, a transaction fee of 3.5% will apply to online transactions. The transaction fee is separate payment processing charge and is not part of the contribution amount.

9. Are Friends of DFP members entitled to early access?

Yes. A Friends of DFP early-access period is planned prior to the opening to the general public.

Further information on the early-access period will be communicated through the official DFP/MPO channels.

D. TAX-EXEMPT RECEIPT

11. Is my contribution eligible for a tax-exempt receipt?

MPO is an approved organisation under Subsection 44(6) of the Income Tax Act 1967.

Qualifying cash contributions made to MPO may be eligible for an official tax-exempt receipt, subject to the applicable terms and conditions as per LHDN requirements.

12. How can I obtain my tax-exempt receipt?

- a) Following your contribution, we will email you a **Contribution Donation Form** to obtain the information required for verification and processing.

For qualifying cash contribution, an official tax-exempt receipt may be issued upon receipt and verification of the completed form. Please submit the completed form within one (1) week.

- b) Alternatively, the required contributor information may be provided at the designated counter during the concert for verification and processing of the tax-exempt receipt.

Note: Donors are advised to retain the original tax-exempt receipt for their won records and tax purposes. MPO will not be responsible for any loss or misplacement of the original receipt after it has been issued to the donor.

E. CONCERT EXPERIENCE

13. Will there be any activities before the concert?

A pre-concert light cocktail is planned at the Level 2 and Level 2M foyer areas.

Further details will be communicated to attendees closer to the event date.

14. What is the dress code?

Dress Code: Smart Casual

Strictly no torn jeans, shorts, collarless T-shirts and sweatshirts, singlets, sports attire, slippers or flip-flops.

15. How long will the concert be?

The concert is expected to run for approximately 120 minutes, including a 20-minute intermission.

16. Will photography or video recording be allowed?

Photography, audio recording and video recording are not permitted during the performance unless officially authorised.

Guests may take photographs before and after the concert and during the intermission, subject to applicable venue guidelines.

17. Will a meet-and-greet session be available?

No. A meet-and-greet session is currently not planned for this concert.
